2020 CAMP FINANCIAL ASSISTANCE APPLICATION

Welcome to Watertown Boys & Girls Club's financial assistance program. Due to the number of requests for assistance for our summer camps, we have a few rules to ensure that we can serve as many requests as fairly as possible. Please read through the following:

CAMP FINANCIAL AID POLICY:

If you are applying for financial assistance you must complete and turn in this application by **May 1st, 2020**.

Please also submit a completed registration form, along with a \$50 non refundable deposit per week. Your deposit will be applied to your camp balance.

Financial assistance is based on need and available funds. *It is not* first come first served. Applications are due by May 1st, and decisions will be made by June 15th. Applications received after May 1st will be added to a waitlist and considered depending on available funding.

If you are awarded any other assistance through any other outside source, your financial assistance award will be based on the amount after your outside assistance has been deducted.

If you do not qualify for financial aid, we will be happy to set up a payment plan with you. You will be responsible for payment in full.

A current membership is required to attend any Watertown Boys & Girls Club Camp. Summer memberships are \$10 and cannot be waived.

Decisions regarding financial assistance will be completed June 15th and we will notify you by email. Full payment for any balance due after applied discount will be due two weeks before the start of the given session. Failure to pay balance on time will result in the forfeiture of both your camp slot and your financial aid.

We are a privately funded organization with limited resources. In order for us to provide financial assistance to our campers, we rely on donations from our generous Club supporters. Please know that we have an overwhelming number of requests for assistance for our summer camps and we do our best to distribute this financial aid to best assist all families that apply and qualify. While you may ask for more weeks or more assistance than we are able to provide, we ask for your understanding in this matter.
